Deepak Fertilisers' Q4 standalone PAT jumps 112%

DEEPAK FERTILISERS AND Petrochemicals Corp's (DFPCL) standalone PAT jumped 112% to ₹54.07 crore during Q4FY18. Total income during Q4FY18 grew by 89% to ₹1,174.40 crore, while PBT grew by 29% to ₹49.95 crore.

On a consolidated basis, the company's total income grew 53% to ₹1,916.33 crore in Q4FY18, driven by increase in TAN and solvent trading volumes; PAT stood at ₹38.98 crore, which was a 20% y-o-y growth. Higher raw material cost in Q4FY18, especially for ammonia and natural gas, which increased by 32% and 25%, respectively, on a y-o-y basis, impacted the profitability.

DFPCL's FY18 revenues went up by 38% to ₹6,061 crore against ₹4,378 crore in the previous year. The company has announced expansion of a brownfield IPA plant in Taloja and launched the Smartek range of value-added fertilisers.

DFPCL's CMD Sailesh C Mehta said the company was on a transformation journey to move from commodity offering to value-added solutions and it was shaping as per expectations. "Currently, our management consulting partners are testing various hypothesis that would help us move from product-based pricing to value-based pricing across segments, thereby improving the contribution margins," Mehta said.

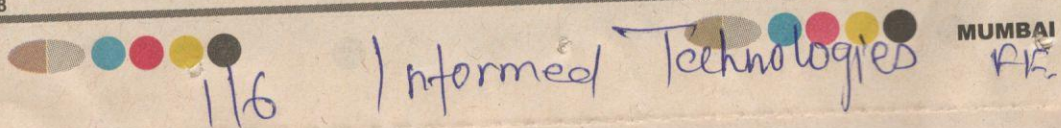
